A complete set of bidding documents may be purchased by interested bidders on the submission of a written application, along with the copy of Company/Firm Registration Certificate and upon payment of a non refundable fee as shown in above table deposited in the current Account No. 00051040015275 at Laxmi Bank Ltd, Hattisar, Kathmandu or in the form of draft drawn in favor of the "Hetauda-Dhalkebar-Duhabi 400kV-NEA". If so requested, the Bidding Documents can also be sent by post/courier upon payment of additional cost of NRs. 1,000 (in words Rupees One Thousand). However, the Employer will not be responsible for any delay or non- delivery of the documents so sent.
5. Bids must be submitted to the Project on or before as shown in the above table. **Documents received after this deadline shall not be accepted.**
6. Bids shall be opened in the presence of Bidders' representatives who choose to attend at time and date shown in the above table at the address of the office given below. Bids must be valid for a period given in the above table after bid opening i.e. September 24, 2018 and must be accompanied by bid security, amounting not less than the value given in the above table which shall be valid for 30 days beyond the bid validity period i.e. October 24, 2018. The bank guarantee shall be issued by commercial banks in Nepal.
7. If the last date of submission and opening falls on an official holiday then it shall be extended to the next working day. In such case the validity of bid security shall be considered from already specified last date for bid submission.
8. Bidders are advised to visit site and assess the actual site conditions before submitting their bid.
9. NEA reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
