Invitation for Bids for the **Permanent Camp Facility Construction Works**

1. The Government of Nepal [GoN] and NEA **has allocated funds** towards the cost of Tamakoshi V Hydroelectric Project and intends to apply part of the funds to cover eligible payments under the Contract **for Permanent Camp Facility Construction Works, Contract Identification No: TKJVC/076-77/IFB-02**. Bidding is open to all eligible as per Section V of bidding document.
2. **Tamakoshi Jalvidhyut Company Limited** invites electronic bids from eligible bidders for the construction of **Permanent Camp Facility Construction Works** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. 35,00,00,000.00 (Thirty Five Crores Rupees Only)**
- Minimum Work experience of similar size and nature: Participation as Prime contractor, management contractor, or subcontractor, in at least 2 (Two) Contracts within the last ten (10) years, each with a value of at least **NRs. 26,00,00,000 (In Words : Twenty Six Crore Rupees Only)** in Construction Works for Camp Facilities/Building Work. Such constructed camp facilities /Buildings should have at least 7 (Seven) number of quarters/ buildings or equivalent to size of buildings must be stated in scope of works. That have been successfully or are substantially completed and that are similar to the proposed works. The similarity shall be based on the physical size, complexity, methods, technology or other characteristics as described in Section VI, Works Requirements.
- **In Case of JV**, Participation as Prime contractor, management contractor, or subcontractor) in Construction Works for Camp Facilities/Building Work. Such constructed camp facilities /Buildings should have at least 4 (Four) number of quarters/ buildings or equivalent to size of buildings must be stated in scope of works. That have been successfully or are substantially completed and that are similar to the proposed works. The similarity shall be based on the physical size, complexity, methods, technology or other characteristics as described in Section VI, Works Requirements.

6. Electronic bids must be submitted to the office Tamakoshi Jalvidhyut Company Limited through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 hours (local time)** on **28th April 2020 (16th Baisakh 2077)**. Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 PM** on **28th April 2020 (16th Baisakh 2077)**. at the office of Tamakoshi Jalvidhyut Company Limited , House No. 106, Okharbod Marg, Thapagaun. Bids must be valid for a period of **120 Days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 92,00,000 (Ninety Two Lakh Rupees)** , which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
