We confirm with China Embassy in Nepal that indicate we need to go through the process in China and get the authenticate from Nepal Embassy in China. The process is first certified by notary agency and sending the original notarized documents to Department of Consular Affairs of the Chinese Ministry of Foreign Affairs do consular authentication, after that, the original certified documents arrive in Nepal Embassy in China to get the final authentication. Could you pls accept the notarial certificate be authenticated by Nepal Embassy in China? As for Chinese Embassy Policy, this certificate authenticated by the Nepal based Embassy of China is not available. As Chinese company we can only get certificate from Nepal Embassy in China. We want to know if we follow the policy in China government and get certificate from Nepal Embassy is accept or not?	The authentication of the notarial certificate by the Department of Consular Affairs of the Ministry of Foreign Affairs of China or authorized Foreign Affairs Offices of local governments, and then the legalization by the embassy or consulate of Nepal as per the regulation of the government of the People's Republic of China is acceptable to NEA.
