 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs 15 million.**
 - Minimum Work experience of similar size and nature: **at least One (1) contract within the last Three (3) years, each with a value of at least NRS 2.36 million Without VAT.**
 - Construction Experience in Key Activities: **Have been successfully completed Supply or installation of EOT crane of Value NRs. 1.12 million, Without VAT.**
