- The Government of Nepal has received the financing from Asian Development Bank (ADB) toward cost of SASEC Power Transmission and Distribution System Strengthening Project. Part of this financing will be used for payments under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.
- 2. The **Nepal Electricity Authority** ("the Employer") invites sealed bids from eligible bidders for the "Supply, Installation, Testing and Commissioning of Parwanipur-Pokhariya 132 kV Transmission Line."
- 3. **Open Competitive Bidding (OCB) -** International Advertisement will be conducted in accordance with the ADB's Single Stage-Two Envelope bidding procedure and is open to all eligible bidders from eligible countries as described in the Bidding Document.

5. To purchase the bidding documents in English, eligible bidders should:

Write to address above requesting the bidding documents for PMD/PTDSSP/HPP/2080/81-01: Supply, Installation, Testing and Commissioning of Parwanipur-Pokhariya 132 kV Transmission Line. If the bidder is purchasing the bid document through their Local representative, an authorization letter shall be submitted indicating authority delegated to the local representative.

 Pay a non-refundable fee of NRs. 20,000.00 or an equivalent amount in US\$ by bank voucher to the Account No. 9990078101300014 (HETAUDA-PARWANIPUR-POKHARIYA 132 KV PRASARAN LINE AYOJANA) at the Machhapuchchhre Bank Limited, Satungal, Kathmandu, Nepal.

- 6. Deliver your bid:
  - To the address above on or before the deadline: 15 May 2025, 12:00 Hours (Nepal Standard Time).
  - Together with a Bid Security with amount indicated in Bidding Document Section 2 Bid data Sheet, Clause ITB 21.1.

Technical Bids will be opened at the Project Manager's Office on 15 May 2025 at 12:30 hours (Nepal Standard Time) in the presence of bidders' representatives who choose to attend, whereas the Price Bids shall remain sealed and unopened and shall be placed locked. The Price Bids of only Technically Responsive and Qualified Bidders shall be opened after technical bids evaluation, whereas the Price Bids of those bidders whose Technical Bids are not responsive and qualified shall be returned unopened after the contract is awarded.

7. When comparing Bids, ADB's Domestic Preference Scheme will be applied in accordance with the provisions stipulated in the Bidding Document.
