The Government of Nepal has received financing from the Asian Development Bank (ADB) toward the cost of **South Asia Subregional Economic Cooperation Electricity Transmission and Distribution Strengthening Project (ETDSP)**. Part of this financing will be used for payments under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The **Nepal Electricity Authority** ("the Employer") invites sealed bids from eligible Bidders for the construction and completion of "**Design, Supply, Installation and Commissioning of the NEA Digital Network and SCADA Expansion**".
3. **Open Competitive Bidding (International advertisement)** will be conducted in accordance with ADB's [Single-Stage: Two-Envelope](#) procedure and is open to all Bidders from eligible source countries as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications defined in the bidding document may participate in this bidding:

Bidders shall have minimum average annual turnover of US\$ 22.42 Million. Bidders are required to have satisfactorily completed contracts within the last ten (10) years and that are similar to the proposed works, where the value of the Bidder's participation meets USD 25.63 Million in One (1) Contract OR cumulatively USD 25.63 Million (not more than three (3) contracts).

- Write to address above requesting the Bidding Documents for PMD/ETDSP/NDNSEP-082/83-01: Design, Supply, Installation and Commissioning of the NEA Digital Network and SCADA Expansion (Package No. P-13). Any bidder purchasing the bid document through their Local representative, an authorization letter required to be submitted indicating authority delegated to the local representative.
- Pay a non-refundable fee of **NRs. 20,000.00** (incl. VAT) or an equivalent amount in US\$ by bank voucher to the Account No. 00201017505586 (NEA-PROJECT MANAGEMENT DIRECTORATE SELF) at the NABIL Bank Limited, (SWIFT CODE NARBNPKA) Nepal.

- together with a Bid Security with amount indicated in Bidding Document Section 2 Bid data Sheet, Clause ITB 21.1.

Technical Bids will be opened at the Project Manager's Office on 9th April 2026 at 12:30 hours (Nepal Standard Time) in the presence of Bidders' representatives who choose to attend, whereas the Financial Bids shall remain sealed and unopened and shall be placed locked. The Financial Bids of only Technically Responsive and Qualified Bidders shall be opened after technical bids evaluation, whereas, the financial bids of those bidders whose technical bids are not responsive and qualified shall be returned unopened after the contract is awarded.
