6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 03-07-2026 14:00 at the office of NEA, Bagmati Province, Province Division Office, Hetauda Bhutandevi-10 Hetauda, Makwanpur Bagmati Province Nepal.
Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of 54000 , which shall be valid for 30 days beyond the validity period of the bid (i.e. [Refer Clause ITB 20.1]). If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No.[00201017505465] at [Nabil Bank Ltd. , Hetauda , Makawanpur] and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
