1. Nepal Electricity Authority (NEA) has allocated funds towards the cost of Supply and delivery of Line Materials and Hardware and intends to apply the funds to cover eligible payments under the Contract for NEA/BPDOH/2082/083-04: Supply and Delivery of Line Materials and Hardware. Bidding is open to all eligible Nepalese Bidders.
2. Nepal Electricity Authority, Bagmati Province Division Office invites procurement of Line Materials and Hardware under bids from eligible bidders for the procurement of under National competitive bidding – Single Stage Single Envelope procedures.
3. Eligible Bidders may obtain further information and inspect the bidding documents from PPMO eGP system www.bolpatra.gov.np/egp.
4. A complete *set* of Bidding Documents may be purchased from the www.bolpatra.gov.np/egp by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the following Rajaswa (revenue) account as specified below .

5. Electronic bids must be submitted to the office through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 on 7/17/2026** Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 7/17/2026** at the office of Bagmati Province Division Office. Bids must be valid for a period of **90 days** from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. **490,000.00** which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a public holiday¹ applicable to purchaser, then the next working day shall be considered as the last date. In such case the validity period of the **bid and** bid security shall remain the same as specified for the original last date of bid submission.

¹ In case of electronic bid invitation, purchaser shall extend the deadline as required in the e-GP system.
